## FROM THE TREASURER

### EFFECTIVE 15 OCTOBER 1993.

As a result of several members maintaining fairly high overdue balances, the Board of Governors has established the following policy:

MEMBERS WHO ARE OVERDUE BY \$300 OR MORE WILL NOT BE ALLOWED TO CHARGE AT THE LBYC. IF STILL OVERDUE BY \$300 OR MORE THE NEXT MONTH, ALL GYA CLUBS WILL BE NOTIFIED THAT THE MEMBER IS NO LONGER IN GOOD STANDING AND CHARGES FOR THEM WILL NOT BE ACCEPTED.

MEMBERS IN THIS CATEGORY CAN PAY THEIR CHARGES AND WILL AGAIN BE ALLOWED TO CHARGE AT THE CLUB.

THE NAMES OF MEMBERS WHO HAVE OVER \$300 OVERDUE CHARGES FOR THE THIRD STRAIGHT MONTH WILL BE SUBMITTED TO THE BOARD OF GOVERNORS FOR TERMINATION PROCEDURES. ANY AND ALL AMOUNTS OWED, INCLUDING DUES TO THAT POINT, WILL BE IMMEDIATELY DUE AND PAYABLE.

This policy is effective 15 October 1993 and does not rescind or modify other policies currently in effect. Members whose names are submitted for termination procedures may appeal to the Board of Governors as to why their membership should not be terminated.
